Rental Agreement, and its directors, officers, employees, instructors, agents, representatives, volunteers, independent contractors, subcontractors, sponsors, successors and assigns (hereinafter collectively referred to as to "Releasees")

1. I accept full responsibility for the care of the rental equipment ('the Equipment') listed on this form and I agree to pay for any damage to the Equipment and replace at full retail value any Equipment not returned by the agreed date.
2. I also agree to return the Equipment in clean condition to avoid any additional charges.
3. (SKIERS ONLY) I have made no misrepresentation in regards to my height, weight, age or skier type. (This information is required in order to properly adjust the ski boot/binding settings).
4. I am familiar with the proper use of the Equipment. I understand that the rental technicians are able to answer any questions I may have as to the proper use of the Equipment.

Assumption of Risks

I am aware that alpine skiing, snowblading, snowboarding and snowshoeing involve risks, dangers and hazards and that injuries are a common and ordinary occurrence of the sports.

ALPINE SKIING I understand that the ski boot/binding system will not release at all times or under all circumstances, that it is not possible to predict every situation in which the system will release, and that the system is no guarantee that the user will not be injured.

SNOWBLADES I understand that the ski boot/binding system will not release at all times or under all circumstances, that it is not possible to predict every situation in which the system will release, and that the system is no guarantee that the user will not be injured.

Adult snowblade models (85cm and longer), are not recommended for people less than 5 feet tall (1.5 meters), and especially not for children less than 5 feet tall (1.5 meters). Snowblades are not designed for backcountry or deep snow applications.

SNOWBOARDING I understand that the snowboard boot/ binding system is not designed or intended to release and will not release under normal circumstances. I understand that as the snowboard boot/ binding system is a non-release system, it will not reduce the risk of injury during a fall.

SNOWSHOEING I understand that the boot/binding system for this equipment is not designed or intended to release under normal circumstances. I understand that as the boot/binding system is a non-release system, this system will not reduce the risk of injury during a fall and will increase the risk of not surviving an avalanche.

HELMETS I understand that a helmet designed for RECREATIONAL SNOW SPORTS use will help reduce the risk of some types of injuries to the user at slower speeds. I recognize that serious injury or death can result from both low and high energy impacts, even when a helmet is worn.

**I FREELY ACCEPT AND FULLY ASSUME ALL RISKS, DANGERS AND HAZARDS ASSOCIATED WITH THE USE OF THE EQUIPMENT.
RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT**

In consideration of the rental of the Equipment, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may have in the future against Chicopee Ski Club and the manufacturer and distributor of the Rental Equipment and their directors, officers, employees, instructors, agents, representatives, volunteers, independent contractors, subcontractors, sponsors, successors and assigns (all of whom are hereinafter collectively referred to as "the Releasees") and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin may suffer as a result of or arising out of any aspect of my use of the Equipment, *DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT OR BREACH OF WARRANTY ON THE PART OF THE RELEASEES* in respect of the design, manufacture, selection, installation, maintenance or adjustment of the Equipment, or in respect of the provision of or the failure to provide any warnings, directions, instructions or guidance as to the use of the Equipment;
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any loss, damage, injury or expense to any third party, resulting from the use of the Equipment;
3. This Agreement shall be effective and binding upon heirs, next of kin, executors, administrators, assigns and representatives, in the event of my death or incapacity;
4. This Agreement shall be governed by and interpreted in accordance with the laws of the Province of Ontario; and
5. Any litigation involving the parties to this Agreement shall be brought within the Province of Ontario.
6. I hereby irrevocably consent to and authorize the use and reproduction by the Chicopee Ski Club, or anyone authorized by them, of any and all photographs or video which have been taken of me and/or my children. The photographs/video may be used for any purpose authorized by the Chicopee Ski Club, including but not limited to website use, editorial publication and any and all advertising purposes.
